COLLECTIVE CSA 1st January – 31st May of any year.	3.2	TERM Grower may give Notice of Termination of CSA contract eg. "If a Notice of Termination is given by a grower on 28 May 2018, the CSA will terminate when the Final Adjustment Payment is made in respect of the 2019 Crushing Season provided grower has not nominated a GEI Sugar marketing nomination for 2020."
INDIVIDUAL CSA 1st January – 28th February of any year.	3.2	TERM Grower may give Notice of Termination of CSA contract eg. "If a Notice of Termination is given by a grower on 28 February 2018, the CSA will terminate when the Final Adjustment Payment is made in respect of the 2019 Crushing Season provided grower has not nominated a GEI Sugar marketing nomination for 2020."
COLLECTIVE CSA By 30 th November in a crushing season. INDIVIDUAL CSA By 31 st October in a crushing season.	7.1	STANDOVER CANE Grower may make a written application to the Mill Owner stating reasons for and intention to leave standover.
COLLECTIVE CSA One month prior to planting.	7.3	PROPOSED INCREASES TO CONTRACT AREA If a grower wishes to increase the area of land from which cane will be grown for supply to the Mill Owner, written notice must be provided.
INDIVIDUAL CSA One month prior to planting.	7.2	

COLLECTIVE CSA 1st February – 30th November of any year.	7.4	PROPOSED REDUCTION IN CONTRACT AREA Where a grower wishes to reduce the Contract Area from that specified in Item 8 of Schedule 1 during the CSA term, grower must make application to the Mill Owner stating reasons for the proposed reduction in contract area within this timeline.
ECOLLECTIVE CSA & INDIVIDUAL CSA At least 5 business days prior to 31st July of any year.	8.2	GEI SUGAR MARKETING ENTITIES Grower must give notice to the Mill Owner to provide a draft GEISSA to a new marketer
ECOLLECTIVE CSA & INDIVIDUAL CSA By 30 th September of any year.	8.2	GEI SUGAR MARKETING ENTITIES Mill Owner will post on website details of available GEI Sugar Marketing Entity/ies available for the following season for growers to choose from.
EVALUATION COLLECTIVE CSA & INDIVIDUAL CSA By 31st October of any year.	8.3	NOMINATIONS OF GEI SUGAR MARKEITN ENTITY/ENTITIES Grower may nominate one or more available GEI sugar marketers for up to 3 seasons, Mill Owners will advise the marketer of that nomination, eg. "Grower must make its GEI Sugar Marketing Entity nomination no later than 31st October 2021 for the 2022 relevant season". Grower is free to amend any nomination up until 31st October in the year prior to the relevant season.
