QSL Market Update

Sugar prices retraced almost a third of their 300-point October rally last week before a recovery on Friday saw the MAR19 prompt contract finish in the middle of its 14.05c/lb-13.08c/lb weekly range at 13.44c/lb. Despite the backdrop of improved fundamentals driven by shrinking Brazilian production as their harvest

comes to a rapid close and lower European Union production estimates for next year, the market is wary of improved Brazilian production next year and the impending onset of Indian sugars, with their crush due to commence this month. As such, we will likely see the market trade between ethanol parity (14.50c/lb) and Indian export thresholds (12.50c/lb), taking direction from macro and technical influences.
