Pricing nominations close this month

Growers wishing to use QSL's optional managed pools or self-managed pricing products for the 2019 Season are reminded they must finalise their nominations this month. After this time, any unallocated 2019-Season GEI Sugar tonnage will default to the QSL Harvest Pool.

This nomination deadline - known as the Pricing Declaration Date - is also the last opportunity for growers with existing unfilled orders in the 2019-Season Target Price Contract to cancel or reallocate these to alternate pricing options. Growers using the Individual Futures Contract can also cancel or reallocate unfilled 2019-Season orders before the Pricing Declaration Date, but only if no portion of the order has been filled.

It is important to note that while QSL's 2019-Season Pricing Declaration Date is **30 April 2019**, local nomination deadlines apply to growers supplying Bundaberg Sugar, Isis Central Sugar Mill and Mackay Sugar's Mossman Mill, as outlined below:
