### **Adjustment for Mackay growers**

QSL processed a PRS adjustment for Mackay growers on Monday. In some cases this adjustment also included additional allowances and/or deductions from your miller. While QSL has issued an Adjustment Statement for this amount, growers should refer to their mill paperwork for full details. Mackay growers are also reminded that to reconcile their QSL and miller payment statements, they need both the RCTI and **Cane Payment Summary** provided by their miller.

Growers marketing with QSL can now access pricing for the 2022 Season as well as additional tonnages for the 2020 and 2021 Seasons. Please contact your local QSL representative for further information about your grower-managed pricing options. GEI Sugar pricing limits for forward seasons are:

- 2020 Season: Up to 60% of your GEI Sugar estimate
- 2021 Season: Up to 50% of your GEI Sugar estimate
- 2022 Season: Up to 40% of your GEI Sugar estimate

### **QSL Market Update**

A monster 800,000-tonne delivery for the August London Whites expiry confirmed that there is plenty of sugar struggling to find a home in the physical trade flows. In India, Maharashtra has experienced weaker oil and grain prices,

along with some much needed rain in coastal areas, providing a bearish backdrop for the market. Elsewhere, the Brazilian Real has remained firm at around 3.75, although this is largely irrelevant with sugar prices already so far below ethanol parity.
