# February 2020 Guaranteed Floor Pool

## **Nominations closing**

Nominations for QSL's new February 2020 Guaranteed Floor Pool close at **4pm tomorrow**, **Thursday 20 February 2020**.

Like its standard counterpart, QSL's February 2020 Guaranteed Floor Pool offers growers a guaranteed minimum return or 'floor', as well as 50% participation in any pricing achieved above a set 'strike price'.

While the floor and strike prices will not be known until after nominations close, QSL is publishing indicative prices on both its homepage (<a href="www.qsl.com.au">www.qsl.com.au</a>) and within its Daily Price Update email to give growers an indication of potential floor levels.

Should the final floor achieved after nominations close be more than \$10 less than tomorrow's indicative floor price, the pool will be cancelled and growers will have the opportunity to reallocate their nominated tonnage to another 2020-

Season pricing option.

The current indicative February 2020 Guaranteed Floor Pool prices, as of today (19 February 2020) are:

FLOOR PRICE	470.66 AUD/tonne ACTUAL
The absolute minimum gross price return of the pool.	(454.22 AUD/tonne IPS)
STRIKE PRICE	483.22 AUD/tonne ACTUAL
A participation rate of 50% applies when the market exceeds the Strike Price.	(466.34 AUD/tonne IPS)
