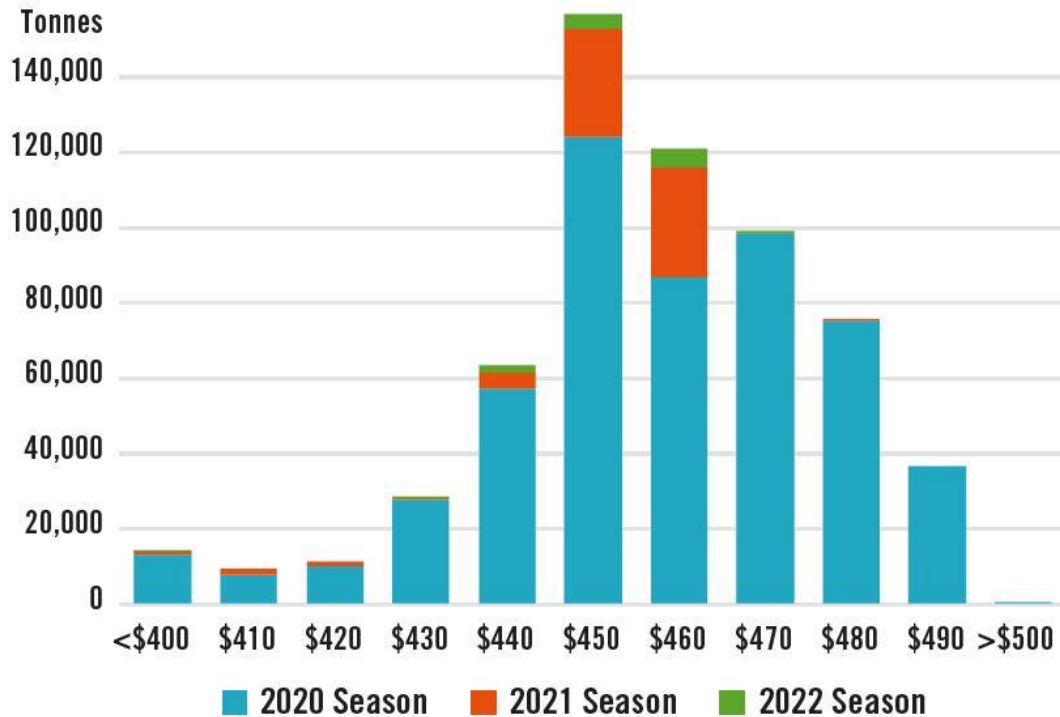
QSL advance rate increases

- QSL's 2020-Season Standard Advance Rate will increase from 72.5% to 75% from 16 December 2020.
- The QSL's 2020-Season Accelerated Advances Program rate will increase to 90% for participants from 16 December 2020. The Accelerated Advances rate will then remain at 90% until the QSL Standard Advances rate also reaches 90% (usually in May the following year), when the rate aligns with the QSL Standard Advances rate for the remainder of the season.
