Please find below a short news & information brief from QSL that you may wish to use in your communications to your members.

- **Target Price Contract** – roll ahead: QSL is now publishing the indicative roll adjustment for growers using the 2020-Season QSL Target Price Contract.
Monday, 22 February 2021 is the final day for these growers to achieve 2020-Season targets before any unpriced tonnes are automatically transferred (rolled) into the next contract. Rolling extends the time growers have to achieve their pricing, but costs may apply. The indicative roll adjustment is published on the QSL Direct portal, the QSL Daily Price email and the QSL website. To see the latest indicative roll adjustment, please [click here](#).
- **Cash Flow Forecaster temporarily unavailable:** Please be advised that the QSL Cash Flow Forecaster is currently unavailable due to technical issues. - **Pre-Crush Advance Payment Scheme:** The QSL Pre-Crush Advance Payment Scheme is now open for nomination. Participating growers can receive \$50/tonne of sugar IPS on 26 March for up to half of their 2021-Season QSL GEI Sugar. Nominations close 12 March. To find out more, [click here](#).

 - **15 February 2021**
QSL Individual Futures Contract & Self-Managed Harvest Contract Pricing Completion Date: The pricing completion date for the Mar 21 contract for the 2020 season is 15 February. Any unpriced tonnage after this date will be priced by QSL at the next market opportunity.
 - **22 February 2021**
QSL 2020 Target Price Contract: Any unfilled orders will be rolled to the May 21 Contract after 22 February. Adjustments may apply.
