

Please find below a short news & information brief from QSL that you may wish to use in your communications to your members.

- 2021-Season Pricing Declaration Date: The 2021-Season Pricing Declaration Date is Friday 30 April 2021. This is the last day for growers to nominate to their chosen QSL-Managed and/or Grower-Managed pricing products for the 2021 Season. Any tonnes that remain unallocated after 30 April will default to the QSL Harvest Pool.

- Defaulting Target & Grower Floor orders: Growers using the 2021 Defaulting Target Price Contract and/or 2021 Grower Floor Price Contract are reminded that any unfilled orders have now been cancelled and the associated tonnage has defaulted to the 2021 Harvest Pool. This tonnage can be still allocated to other QSL pricing options up until the 2021 Pricing Declaration Date on 30 April 2021. Growers seeking a floor price for the 2021 Season can still nominate tonnes into the April 2021 Guaranteed Floor Pool. Click here for details. - Q3 reports now available: You can now find your quarterly report (Q3) in your QSL Direct
  account under the 'Financial Reports' tab for the 2020 Season. These reports have also been
  distributed in the same manner you usually receive your ledger reports and statements.

- New App features available: A new version of the QSL App had been released to include the new 'Season Preferences' feature. This allows QSL Growers to nominate the Accelerated Advances or Pre-Crush Advance payment options.
   In addition, QSL Growers can now opt into the Self-Managed Harvest Pool.

    - **QSL Pricing Declaration Date:** Last day for growers to nominate to their chosen QSL-Managed or Grower-Managed pricing product/s for the 2021 Season.
