Are you eligible for the QSL Loyalty Bonus?

It's still not too late to lock in your QSL Loyalty Bonus for the 2020 Season. To be eligible, growers marketing with QSL for the 2020 and 2021 Seasons must nominate QSL as their sugar marketer for the 2022 Season by June 30, 2021*.

2021 Target Price Contract roll ahead

This coming **Monday 21 June** is the last day to achieve pricing in the 2021-Season Target Price Contract before the pricing window is automatically extended to 20 September 2021 and a roll adjustment is applied. The current estimated adjustment is -\$0.78 per tonne of sugar.

QSL Advance increase

The 2020-Season June Advance payment was made this week and paid at 98% of indicative returns as of 28 May 2021. The final Advance payment of the 2020 Season will be made next month. 2021-Season Advance payments are currently being paid at 65% of indicative returns.

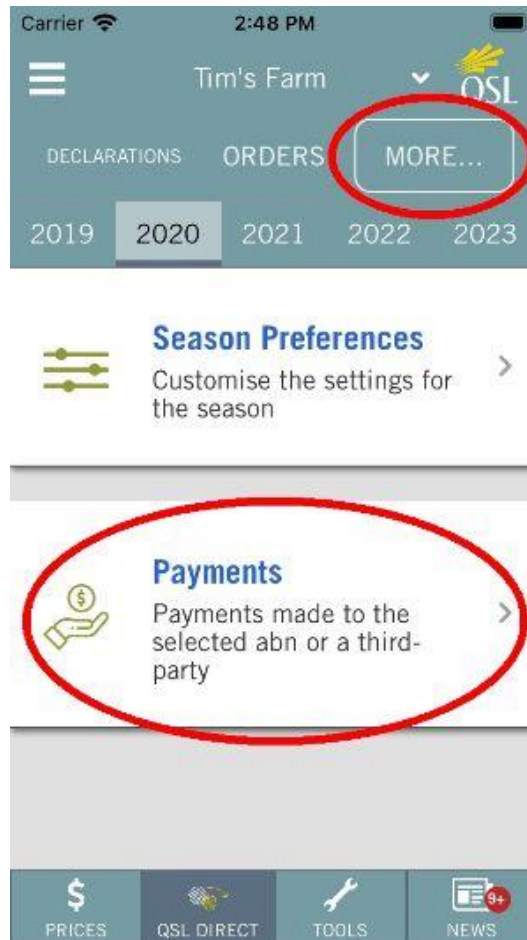
Payment notifications

QSL Direct growers using the QSL App can now receive a notification when QSL has processed a payment for their ABNs. To activate this feature, just ensure that you have:

1. Updated the app; and
2. Enabled notifications

You can check or change your notification status within the **NOTIFICATIONS** section of your phone's **SETTINGS**.

You can find your QSL payment information under the **MORE** tab within the QSL Direct section of the app.



Changes to your farm arrangements

QSL Direct growers planning changes to their farm's operating structure (such as a farm sale, new lease, transfer of entity or subdivision) ahead of the **2021 Season** should advise QSL as soon as possible to ensure QSL payment arrangements reflect these changes. Farm transfers can take up to four weeks to process, with growers and/or solicitors required to complete a Farm Sale/Lease Information Form, [available here](#). Deferred Payment unavailable

Due to the new GST arrangements applicable for QSL growers in Wilmar milling districts from 1 July 2021, QSL's Deferred Payment option is unavailable this year. For details of your payment options for the 2021 Season, please see your local QSL team.

2021-Season Target Price Contract: Any unpriced tonnage in the 2021 QSL Target Price Contract past this date will automatically roll to the October 21 contract. Roll adjustments may apply.

30 JUNE

2020-Season Loyalty Bonus: Last day to qualify for the 2020-Season Loyalty Bonus. To be eligible growers must nominate QSL as their GEI Sugar Marketer for the 2020, 2021 and 2022 Seasons by this date.*

1 JULY

New QSL statements: New concise and easy-read payment statements rolled out across all QSL Direct districts.

Simplified GST arrangements: Improved payment process commences with simplified GST arrangements coming into effect.
