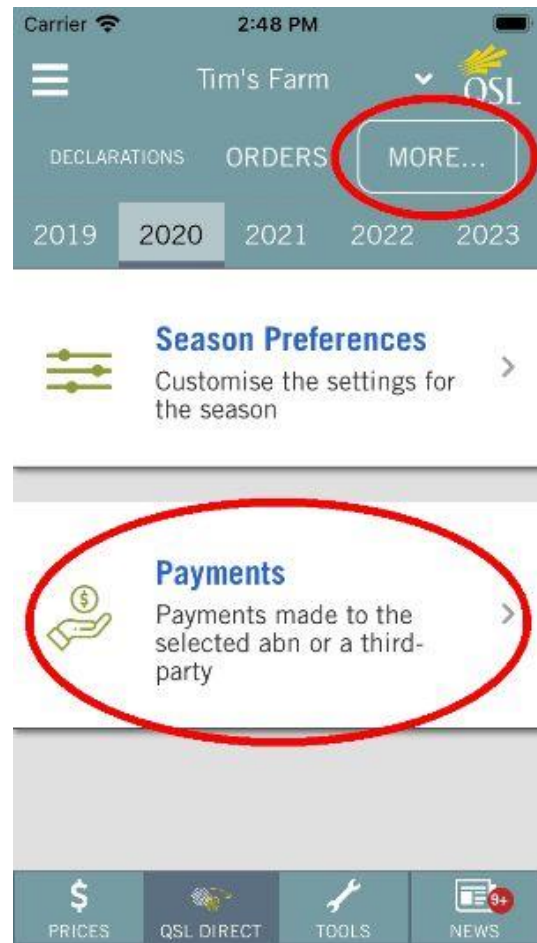


## Payment info now available in QSL App

## KEY DATES



### 15 JUNE

**2021-Season Individual Futures Contract (IFC):** Pricing Completion Date for the July 2021 contract for growers using the QSL Individual Futures Contract. Any unpriced tonnage past this date will be priced by QSL at the next market opportunity.

### 21 JUNE

**2021-Season Target Price Contract:** Any unpriced tonnage in the 2021 QSL Target Price Contract past this date will automatically roll to the October 21 contract. Roll adjustments may apply.

### 30 JUNE

**2020-Season Loyalty Bonus:** Last day to qualify for the 2020-Season Loyalty Bonus. To be eligible growers must nominate QSL as their GEI Sugar Marketer for the 2020, 2021 and 2022 Seasons by this date.\*

\*Applicable only in Marketing Choice districts

## Third-party payments (liens)

Growers in Wilmar milling districts are reminded that any third-party payments they have in place for the 2020 Season will automatically roll into the 2021 Season.

To make changes to these payments for the 2021 Season, please contact your local QSL team or call QSL Direct on 1800 870 756.

## Changes to your farm arrangements

QSL Direct growers planning changes to their farm's operating structure (such

as a farm sale, new lease, transfer of entity or subdivision) ahead of the **2021 Season** should advise QSL as soon as possible to ensure QSL payment arrangements reflect these changes.

Farm transfers can take up to four weeks to process, with growers and/or solicitors required to complete a Farm Sale/Lease Information Form and return it to [QSLDirect@qsl.com.au](mailto:QSLDirect@qsl.com.au).
