

This brings the season-to-date total to just over 2M tonnes – or 25 per cent – of the estimated Burdekin crop.

The weekly result was above budget, despite Inkerman Mill's extended stop to repair leaking boiler tubes and Invicta Mill's stop to carry out repairs to the bagasse system.

Average weekly CCS was 14.28. This was again well above budget thanks to the dry cool conditions.

The highest CCS sample was 17.2 from a rake of Q240 plant cane in the Inkerman Mill area.





# Dr Peter Ridd Facebook Page Post

I've posted the coral cover data for a couple of regions of the reef over the last month, and finally AIMS has gone public with a statement released by environment minister Susan Ley associated with UNESCO's intention to list the reef as "endangered."

AIMS list the northern, central and southern regions as having 27%, 26% and 39% coral cover respectively. Normalising this for the number of reefs surveyed in each section (54, 53 and 30 reefs respectively), this produces a total average coral cover for the GBR of 28%.

This is a record high value, although, given the uncertainties in these numbers one needs to be a little circumspect.

But it certainly does not indicate that there is much wrong with the Reef.

Disgustingly, the Queensland Environment Minister Meaghan Scanlon is claiming credit, reportedly saying in The Australian "... it's a sign of the work we've done to-date around water quality and research."

This has nothing to do with agriculture. No significant amounts of sediment, or pesticides reach the Reef, and there are 100's of times more nutrients cycling across the seabed, or coming in from the Pacific Ocean, than from farm fertilizer. The government could shut down every farm in Queensland, and it would have no impact, on the Reef.


The reason there is high coral cover is that the reef is in good shape because it is not affected by any significant pollution and the impact of climate change has been minimal.

The most important lesson from this is to accept that coral cover changes drastically from year to year. A bad cyclone can reduce it by half. A few good years, and it recovers. Don't make too much of the year-to-year fluctuations and don't let the media, or the scientists who egg them on, tell doom-stories when there is a reduction in coral.

But for goodness sake, tell everybody, especially the children – the Reef is fine. Don't get depressed; don't let them scare you with continuous doom and gloom.

Thanks again to the AIMS long term monitoring team for doing such good, quality assured, work over the last 35 years.







# Sugar Weekly Report



 NY Flat Price: NY#11 sugar market has stopped short term retrenchment and received support with a new fresh wave of frost warning over past weekends. Most active October21 contract was consolidating between 16.80 to 17.20 cts/lb range from Monday to Wednesday, then broke the range on Thursday and closed at 17.71 cts/lb on Friday.



- NY Spread: Nearby NY#11 October21/March22 spread continue to trade in range between -0.37 cts/lb to -0.47cts/lb. Week on week, October21/March22 spread closed marginally higher from -0.38 cts/lb to -0.37 cts/lb.
- London Market: London white sugar market continue to follow NY#11 market. London August contract has expired with 73.5k mt refined sugar being delivered from India.
- COT Report (13/07/2021): As of last Tuesday, specs net long position reduced their net long
  position from previous 222k lots to 193.5k lots. Nearby October contract dropped 74 points
  from 17.84 cts/lb to 17.10 cts/lb during this period. Commercials are buying into it,
  commercial longs increase 12.4 k lots and commercial shorts bought back 23.2k lots short
  position.



- CS Brazil is potentially going to experience another wave of frost early this week.
   Minimum temperatures and danger to sugarcane need to be closely monitored.
- Pakistan's Economic Coordination Committee approved a proposal by the production ministry to import 200,000mt of sugar to build a strategic reserve and stabilise prices.




ISMA released preliminary Indian sugar production forecast. Total sugarcane acreage is estimated to be around 5.455 million hectares in 21/22, which is about 3% higher than 20/21 sugar season's cane area of around 5.288 million ha. 21/22 India Sugar production is expected to be flat around 31 million tonnes against 30.9 in 2020/21, with 3.4 million mt sugar equivalent sugarcane juice being diverted to ethanol production.



Since US quota replenishment import program has been announced, The Philippines domestic sugar prices have started to weaken from May'21 onwards. Philippines domestic sugar price now remain around 1,600 Peso/Lkg.
