Please find below a short news & information brief from QSL that you may wish to use in your communications to your members.

- **New GST Arrangements (Wilmar districts only):**

QSL's new simplified GST arrangements for our growers in Wilmar milling districts kicked off last week. The change is part of a wider program of payment improvements, including more concise, user-friendly statements, and payment information and notifications available via the QSL App.

Under the new GST arrangements, **QSL will now apply GST to QSL transactions and issue an RCTI/Tax Invoice for payments for our growers in Wilmar milling districts.** This enables these growers to now enter their QSL sugar income, expenses and GST information into their bookwork just like any other RCTI, and distribute their GST more evenly through the year.

- **Additional tonnage now available:** As of 1 July 2021, QSL growers can access additional GEI tonnage to price in the 2023 and 2024 Seasons, with committed pricing levels now as follows:

2021 Season	2022 Season	2023 Season	2024 Season
70%	70%	70% (20% increase)	50% (10% increase)

To access QSL pricing, you must first have a GEI Sugar Marketing nomination in place for the season in question. See your local QSL team for details or help with the nomination process.

- **Monthly pricing update:** QSL growers had the chance to once again lock in 2021 Target Price Contract pricing at or above the \$500/tonne level (gross actual) during the past month, as the market rallied in the lead up to the July 2021 contract expiry. Next season has also started to attract pricing interest, with the 2022 Target Price Contract climbing above \$460/tonne in recent weeks.
