Tax time reminder

QSL growers in Wilmar milling districts are reminded that our new GST arrangements came into effect from 1 July 2021. As a result, **our previous tax treatment applies for any 2020 and 2021-Season QSL payments made in the last financial year.**

Remember, the simple rule of thumb is:

Old Statement Format = Old GST Treatment

New Statement Format = New GST Treatment
