BAS reporting in Wilmar milling districts

Growers in Wilmar milling districts completing their BAS are reminded that QSL now applies 10% GST to sugar payments. You can find more information regarding the GST changes and what they mean for your bookwork by <u>clicking here</u>, or by contacting your local QSL team.

Have you finished harvesting your 2021 crop?

If you are a grower who has either cut out or will cut out before your local Mill's crushing conclusion date, please ensure you notify your local QSL team. This helps us with your payments and planning. It is also important for growers in our Self-Managed Harvest Contract who may be eligible to price their production buffer.

QSL GROWER PRICING UPDATE



The much-anticipated UNICA report for the second half of September came in slightly above market expectations, but accumulated season figures are still well behind last year. During the two-week reporting period, 35.3 million tonnes of cane were harvested and 2.2 million tonnes of sugar produced, down 12.57% and 21.52% respectively compared to the same period last year.

Changes to farm arrangements

Planning to buy, sell or lease a farm, or changing your existing business arrangements? QSL Direct growers undertaking such changes need to submit our "Farm Sale/Lease Information Form" to capture any associated changes to payments or their QSL account. This form is not a contract – it simply initiates the documentation process by gathering basic information about the transaction to enable QSL to prepare the relevant Deed of Acknowledgement and/or Deed of Novation, to implement associated pricing transfers. This can be done before, during or after the transaction occurs, but ideally, before the transaction occurs.
