Happy new year and welcome to the first edition of eNewsletter for 2022. In this edition we open bookings for upcoming disease workshops, along with applications for research awards and postgraduate scholarships.



Bookings open for disease workshops

Registrations for **SRA's Identifying sugarcane diseases** workshops in early March are now open.

Two 2-day workshops will be delivered by the biosecurity team and pathologists at SRA's Woodford site in South East Queensland.

Manager – Biosecurity and Disease Screening Dr Nicole Thompson said sessions will include a mix of field activities, group learning and seminars, to teach the fundamentals of sugarcane diseases and pathology.

“The first session is tailored for more experienced advisors and industry staff, and the second for newcomers to the sugarcane industry,” Nicole said. “Both will provide information about how to recognise Australian sugarcane diseases, methods for control, clean seed programs, biosecurity and exotic threats, and the latest research developments.”

Drought Assistance available

Two Future Drought Fund programs, Farm Business Resilience and Regional Drought Resilience Planning, are available to support farmers and regions to build resilience to future droughts.

Under new drought assistance guidelines, growers will not need a drought declaration to access drought preparedness assistance, which will be available anytime. To access the new drought assistance, growers will need to have a Farm Business Resilience Plan, or equivalent, that identifies activities to improve resilience when applying for the drought preparedness grants or loans.

Growers can attend a Farm Business Resilience Program workshop or training run by industry organisations or the Department of Agriculture and Fisheries (DAF) to help develop and implement a plan, write a plan themselves, or engage professional assistance.

3.QRIDA – Drought Preparedness & Farm Management Grants

Posted – 21/1/22



The Queensland Government recently announced the **opening of the new drought grant programs**, which focus on greater drought preparedness.

The new drought assistance has expanded to include eligible primary producers **across all industries**. Under the new guidelines, producers will no longer need a **drought declaration** to access drought preparedness assistance.

Producers will need a **Farm Business Resilience Plan** that identifies activities

to improve resilience when applying for the new drought assistance programs with QRIDA. You can find more information, including a plan template, [here](#).

These grants are the first of more drought support to be made available as part of the drought assistance package. QRIDA will also be administering concessional and interest-free drought loans in early 2022.

Farm Management Grants

Farm Management Grants offer primary producers a 50% rebate on the cost of eligible professional advice up to a maximum of \$2,500 to produce a Farm Business Resilience Plan for their property.

Farm Business Resilience Plans help producers to:

- recognise risks associated with production, including climate and weather (such as drought)
- identify business risks, including financial and market factors, and how to respond to those risks and
- understand personal risks such as workplace health and safety.

To be eligible for assistance, you must:

- be a primary producer as defined in the guidelines
- have paid for the eligible professional advice
- have received the eligible professional advice from 11 November 2021
- have received the eligible professional advice from a suitably qualified adviser(s) who:
 - is not the applicant

- does not have an actual or perceived conflict of interest with the applicant and
- is not employed by an entity owned or partially owned by the applicant.

While these rebates are available to offset the cost of seeking eligible professional advice, they are not available to cover the costs of activities to implement the advice. A Drought Preparedness Grant or a [QRIDA Sustainability Loan](#) may be available for implementation activities.

Drought Preparedness Grants

Drought Preparedness Grants offer up to **\$50,000** as a co-contribution grant to assist primary producers undertake on-farm capital improvements that will improve the drought preparedness of their property.

These grants cover **25% of the cost** of purchasing new permanent capital infrastructure to a cumulative amount of \$50,000 over five years.

The grant aims to assist producers with the cost of implementing improvements identified in their Farm Business Resilience Plan, including:

- water infrastructure, including pipes, water tanks, water troughs, dam construction and/or expansion, drilling a new working bore, water conservation infrastructure and water pumps
- equipment that improves the ability of the business to manage drought and
- any freight or contractor costs to purchase and install equipment or infrastructure, including consumables.

To be eligible for funding, the project will:

- involve the purchase and installation of new permanent capital infrastructure
- improve the ability of the primary production business to prepare for continue to operate in, or recover from, drought conditions
- be a drought preparedness activity listed in your resilience plan for the primary production business and
- not have already commenced the project before the assistance is approved.

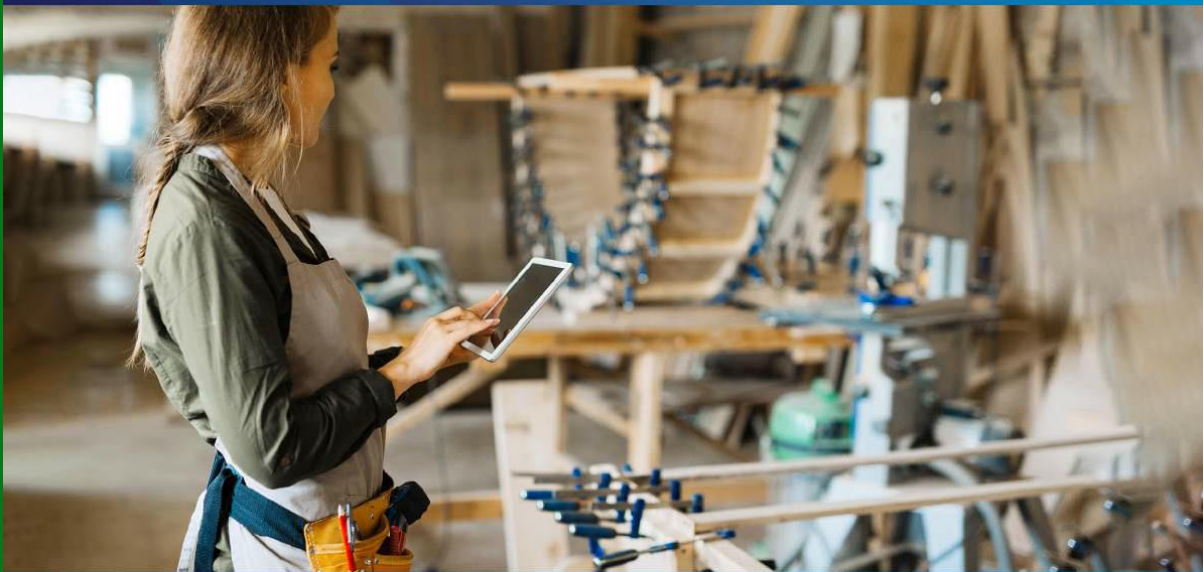

Critically Essential Worker Requirements

The list of critical industries has been expanded, allowing more businesses to identify critically essential roles, where fully vaccinated workers who are a close contact of a COVID-19 case and have no symptoms can leave quarantine to perform that work. The critical industries are:

- Health
- Emergency services, including police, the Queensland State Emergency Service, maritime rescue, the Coast Guard and the Rural Fire Service
- Power and utilities
- Stores in remote locations or communities
- Essential retail (including supermarkets)
- Freight and Logistics, including freight transported by air, rail, road or sea
- Public Transport
- Education – secondary, primary and kindergarten school teachers
- Agriculture and fisheries production
- Resources
- Major manufacturing, distribution and critical supply chains (food, pharmaceuticals and petrol)
- Telecommunications, data, broadcasting and media.

There are three steps for employers to complete when they need to ask a worker to leave quarantine to attend critically essential work.

Domestic border restrictions to lift from 1am Saturday 15 January

The Queensland Government will lift all domestic border restrictions from 1am on Saturday 15 January 2022, as the population reaches 90 per cent double vaccinated. After that time people will no longer need a border pass and negative COVID-19 test to enter the state and there will be no requirement to quarantine if they are unvaccinated. International travel restrictions will remain.

More Queenslanders Eligible for Booster

More Queenslanders are now eligible to get vital booster shots.

Premier Anastacia Palaszczuk has announced that, from Monday, the time between second doses and the vital booster will now be three months instead of four.

More than 60% of eligible Queenslanders have received their boosters.

“We know how vital the booster shot is,” the Premier said.

“It gives that extra immunity.

“Shortening the period between second doses and the booster will give more people more protection.”

The three-month gap is in line with health advice and other jurisdictions in Australia.

\$500 bill discount on offer for tariff talks

Queensland and New South Wales farmers could win one of two \$500 discounts off their energy bills for participating in a research study aiming to better understand how they consider and choose electricity tariffs for their agricultural operations.

The research project is a collaboration between the Queensland Farmers' Federation (QFF) and the University of Queensland, with funding from Energy Consumers Australia, and aims to assist farmers in the tariff decision making process and support greater inclusion of farmers' needs in the design of more flexible tariffs.

QFF President Allan Dingle said the complex tariff configuration, limited offering in rural areas, specific access requirements and multiple electricity meters often made it difficult for farmers and agribusinesses to choose the optimal tariff.

“In order for farmers and agribusinesses to make these important tariff decisions, the agriculture sector requires a better understanding of the challenges around energy use, while also advocating for greater flexibility in the design of tariffs,” Mr Dingle said.

“This study will provide farmers with tools to better select and manage electricity tariffs that lead to reductions in electricity costs and opportunities to manage demand.”

The project partners are seeking farmers to undertake a confidential 30-minute phone or Zoom interview with researchers from the University of Queensland.

Participating farmers will all receive a \$40 gift card with those involved by May 31, 2022 going into the draw for the major prizes.

“The questions will focus on electricity tariffs, options to change them, energy consumption and generation systems. The results will be used to assist in tariff design and the production of materials to assist farmers in evaluating tariff choices,” Mr Dingle said.

“We encourage interested farmers to complete the Expression of Interest form and upload a recent electricity bill and a member of the QFF Energy Savers team will be in touch.”

Growers are reminded that the scheduled Advances increases above are indicative only and may change during the course of the season, and so should not be taken as a commitment by QSL with regard to either the Advance rate or date of increase. The QSL Board reviews the Advances program periodically to determine whether scheduled increases should be approved or amended, weighing factors such as movements in the marketing and shipping plans, sugar price and currency movements and the timing of cash flows. Suppliers' positions in relation to any pricing elections may also impact the timing and size of Advance payments.
