# Guidelines for managing flood damaged cane

SRA has produced guidelines for growers in southern Queensland and northern New South Wales who are trying to decide whether to continue with a crop of cane which was underwater during the recent floods.

The Queensland Government is offering financial help for Queensland farmers affected by the flooding through the jointly funded Commonwealth-State Disaster Recovery Funding Arrangements (DRFA). The NSW Government has also announced storm and flood assistance for businesses.




## A new dawn in Mackay as young growers' group established

# Queensland sugar industry remains a resilient performer

The Queensland sugar milling sector contributed nearly \$4 billion to the Queensland economy in 2020/21, despite COVID, poor global sugar prices, international market distortions and adverse weather.

A new economic report commissioned by the Australian Sugar Milling Council (ASMC) shows the industry remained resilient and stable in those years injecting \$3.8 billion, or more than \$10 million a day, into the economy and supporting nearly 20,000 full-time equivalent direct and indirect jobs.


## Cane Matters publication to launch next month
