NOMINATIONS DEADLINE

Nominations for the following 2022-Season pricing options **close tomorrow***, 30 April.

After this time, any 2022-Season tonnage not nominated to a QSL pricing option will default to the 2022 Harvest Pool.

QSL's new Harvest Pool Opt Out goes live for QSL Direct growers this **Tuesday 3 May**.

To access it, just visit your 2022-Season declaration page within your QSL Direct account and click on the **Opt Out Details** button located beside your Harvest Pool tonnage. You'll then be given a quote detailing:

- How much of your Harvest Pool tonnage has been priced & the value of this
- How much tonnage you can 'opt out' and price yourself through the Self-Managed Harvest Contract
- The tonnage to be priced against the relevant futures contracts in the Self-Managed Harvest Contract

You can then decide whether you'd like to proceed.

The Harvest Pool Opt Out is available each working day between 11am and 3pm. Outside of these hours, you will receive an indicative quote.

Indicative Guaranteed Floor Pool Price

- <u>20 June</u>: 2022 Target Price Contract Roll. Last day to achieve 2022-Season Target Price Contract orders before your pricing window is

automatically extended and roll adjustments apply.

• <u>20 June</u>: July 2022 ICE 11 Contract Pricing Completion Date. Last day to achieve or roll pricing allocated to the July 2022 ICE 11 contract.
