Roll deadline approaching

Growers using the 2022 Target Price Contract are reminded that any unpriced tonnage in this product remaining after **next Tuesday 20 September 2022** will be rolled at the next market opportunity. This extends the time you have to price your nominated tonnage, but a roll adjustment will apply. In order for a grower to achieve their original target after a roll, the market price must reach the target price plus or minus any adjustment associated with the roll.

Rather than being a cost, as is often the case, the current estimated roll adjustment is a positive one. This means that the adjustment reduces the level the market needs to reach to fill orders after the roll. For example, if a +\$5 roll adjustment applied, an order after the roll would be filled when the market reached \$5 less than the order's target price (i.e. A \$500 order would be filled when the market reached \$495). This same roll deadline, 20 September, also applies for unpriced Oct22 Contract tonnage in the Individual Futures Contract and Self-Managed Harvest Contract. Growers using these products can elect to roll up until this date, with any unpriced tonnage remaining after 20 September priced by QSL at the next market opportunity.

- **20 September**: Any unpriced tonnage in the 2022 Target Price Contract will roll after this date and an adjustment will be applied.
- **20 September**: Last day to roll unpriced Oct22 Contract tonnage in the Individual Futures Contract and Self-Managed Harvest Contract. Any unpriced tonnage remaining after this date will be priced by QSL at the next market opportunity.
