2023 Harvest Pool Opt Out now available

The 2023-Season Harvest Pool Opt Out is now available to QSL Direct growers. No minimum tonnage is required – simply choose to Opt Out and any of your Harvest Pool tonnage which has not already been priced by QSL will be transferred to the Self-Managed Harvest Contract so you can price it yourself. Just click the Harvest Pool Opt Out button available within your QSL Direct account to view the current value of your priced Harvest Pool tonnage, how much remains unpriced, and the ICE 11 contracts you'll need to price it against if you decide to opt out and start pricing it yourself.
