

## Parliament Update

As we have seen across the state lately, youth crime and in particularly the violent nature to which it has evolved has been among the top news headlines.

So it comes as no surprise that the government took swift action to introduce legislation around the sale of knives and other weapons to minors in the first sitting of parliament for 2024.

While the new laws may go some way in reducing the incidents of these weapons being carried by a minor, it won't stop those young offenders from taking a weapon from home, making it themselves or arming themselves in the course of committing other offences.

What's just as concerning is the onus the bill will put on small businesses to ensure that these restricted items are secured and not sold to minors.

At the same time we still have a youth justice act that outlines detention as a last resort and as a result, a growing number of serial recidivist offenders that are committing violent crimes across this state.

There is still plenty to do in the space of youth justice and at a time when Queenslander's need the state Labor government to do more to keep them safe we are seeing them once again, stop short of the mark.

**Community frustration turns to petition** 



Frustrations around surging crime rates in our community can not be ignored any longer and I don't plan to let them be.

Recently 50 business owners and community members stood together with one message, 'we've had enough' and I can assure you that is not the end of the campaign.

We've raised our voices before to call for more police in our local stations and those calls cannot fall on deaf ears any longer with a petition launching this week to call for more boots on the ground and more support for security measures.

It shouldn't be left up to residents and business owners to be conducting patrols at all hours of the evening just to ensure cars are still in the driveway and businesses haven't been smashed, but that is exactly what is happening right now.

Just this week the federal government announced that it would provide a North Queensland community with funding to conduct night patrols in a bid to deter youth offending and there is no reason why the same funding can't be provided to the Burdekin.

# Roads left to ruin with funding delays



They're not much, in fact some have been best described as goat tracks, but to us they are vital, they connect communities, industries and essential services.

However time and time again, at a state level, and now a federal level we see the highlighted importance of these roads fall on deaf ears. A \$400million commitment by the previous federal government to seal several beef corridors including the Clermont-Alpha Rd, May Downs Rd and Kilcummin- Diamond Downs Rd, has once again been put on the backburner with funding now not being committed to the project until 2027/2028 and the full project not being completed until 2031/2032.

The sheer fact that communities will possibly have to wait close to five years to see work even begin on these roads is a disgrace and in the meantime we are left with substandard and down right dangerous roads that don't service communities or the industries that rely on it.

We know the townships and industries that rely on these roads are the ones that tip more than their fair share into government coffers so it's only fair that at least some of that share is used to ensure that those people who live and work in these areas can get to their destination and home again safely.

#### Residents deserve reliability

It's not the first time that the need for improved reliability of our local energy network has been brought to the fore but recovery and repairs after Cyclone Kirrily certainly highlighted how badly the work is needed.

Last year as a community we petitioned for improvements to the energy network to be undertaken and while it's taken some time, work is now due to commence in April.

The works will include the replacement of infrastructure including upgrading feeder cables to improve reliability, increase capacity and support future growth.

As I said, the issue of reliability in our energy supply is certainly not a new one and one that we have had to endure for long enough so I will be doing everything I can to hold the government to account and ensure they deliver on their promise without any further delay.
