QSL Loyalty Bonus

Growers who nominate QSL as their GEI Sugar Marketer for 3 consecutive Seasons forward are eligible to receive the QSL Loyalty Bonus.

Since its inception in the 2017 Season, QSL has paid a total of more than \$19 million in Loyalty Bonuses to growers, with this additional payment worth an extra \$1.50-\$2.40/tonne of sugar each season to date. The Loyalty Bonus consists of a share of the returns from QSL's corporate activities via the Shared Services Rebate, with these results incorporated into eligible Growers' Shared Pool allocations for each applicable season.

Are you eligible for the 2023-Season Loyalty Bonus?

Growers who have elected QSL as their marketer for the 2023 Season are eligible to receive QSL's Loyalty Bonus in the 2023 Season if they also have marketing nominations in place with QSL for the 2024 and 2025 Seasons by **30 June 2024**.

QSL Quarterly Ledgers now available

Changes to your farm structure or thirdparty payments?

It's important for QSL Direct growers who are planning any changes to their farm's operating structure to inform their local QSL team as soon as possible. This includes changes to ABNs and farm ownership. Growers are also reminded that all third-party payment arrangements they have in place for the 2023 Season with QSL will automatically roll into the 2024 Season. If there has been any change to your third-party payment arrangements, including extension or expiration of lease and share farming agreements, please let us know.

2024-Season pricing options reminder

QSL Growers have until **30 April 2024** to nominate which pricing options they would like to use for the coming season. In addition to their share of the highly lucrative US Quota Pool, growers can choose from a combination of QSL-managed and grower-managed pricing options. QSL Direct growers can nominate GEI Sugar tonnes to these products via the QSL App or portal. Growers in non-QSL Direct regions can nominate via their Miller's nomination forms. Any GEI Sugar tonnes not nominated to a pricing option after 30 April 2024 will default to QSL's Harvest Pool.
